22nd December 2020





Coronavirus is at a very high level in Wales

This means:

We must only go out for food, education, care, health or work, if we can't work from home

We must only travel if essential

We must not meet people we do not live with, either indoors or outdoors. A person living alone or a single parent can form a support bubble with one other household

When we go out we must keep our distance, wash hands regularly and wear a face mask where required

We must self-isolate immediately and request a test if we develop Covid symptoms

Non-essential retail, including close contact services, leisure, gyms, hospitality and holiday accommodation are closed

These Level 4 rules will remain in place until coronavirus numbers fall

The safest way to spend Christmas is at home with our immediate family, but for Christmas Day only, 2 households will be able to join together. If you are joining with another household, remember to avoid close contact, open windows whenever you can and wipe surfaces regularly.

Business grants –

Latest on the Business Restrictions Fund

If you own a hospitality, tourism or leisure business, or are part of their supply chain. APPLY NOW. https://www.monmouthshire.gov.uk/restrictions-business-fund/ However, if you received a Firebreak Lockdown Grant you will automatically receive a payment and do not need to apply.

The Welsh Government has confirmed that the Restrictions Business Fund will be enhanced to provide additional specific support to non-essential (NDR) retail businesses forced to close by the latest regulations.

If you are a "non-essential" retailer who received an NDR (Non Domestic Rated) linked grant under the recent Firebreak Lockdown scheme then you will not need to reapply for this new grant. A payment of either £3,000 or £5,000 will be automatically paid to you week commencing 4th January 2021.

Non-essential retail businesses forced to close who did not apply for the NDR Firebreak Lockdown grant will need to complete a short application form. This form will be available on our website in the first week of January 2021.

If you are under the non-essential retail category and wanting to apply for this grant please do not complete the application form currently on our website. This form is intended for hospitality, leisure and tourism businesses affected by the restrictions announced on 4th December 2020.
