They did agree to hold a consultation/information giving event with residents which I unfortunately couldn't attend.
- Had a site meeting with Roger Joy regarding lighting for the footpath on the three fields
 (MUSLA/Community centre) site. The Clerk and Cllr Plow also attended. Very encouraging –
 waiting for Roger Joy to get back to us with a design and cost statement to present to both
 the community council and MUSLA to work out funding options.
- Hopefully Horse warning signs will soon be up on the causeway. Have chased this up twice this month now.
- Had lots of contact from RES regarding a potential wind turbine development in the area.
 Am yet to have a meeting with them should do soon though will update you in my
 September report!

UAFC-

- Attended the monthly meeting, warm thanks for invoice issue being sorted out, concern regarding leasing issue with MCC not me personally – will support them if/when needed but currently issue isn't active.
- Sent a letter of support for corporate sponsorship and organised for one to be written on behalf of community council.
