- Officer meeting about Rockfield Farm Met with officers about lease issues, timescales and intentions. Informative and a good result overall for the short term. Continuing to work constantly on the rockfield farm development getting the best for the community.
- **Joint Advisory Group** A short meeting with the unions about their rights within Monmouthshire Council.
- Home Zone Meeting Attended the Home Zone meeting of the Community Council.
- **Undy School Shortlisting** In my role as governor attended a shortlisting session for the new yr2 teacher.
- Officer meet about CAT Met with officers about the CAT draft and some leasehold issues, informative.
- **Undy AFC & MCC meet** Met with committee members from Undy AFC along with MCC officers regarding the possibility of the club applying for a CAT and its lease.
- MAGOR meeting Meeting of the MAGOR rail group which discussed many issues around the dream of a railway station in Magor/Undy.
- **Undy AFC trustee meeting** Met with some of the trustees of Undy AFc to clarify matters from joint MCC meeting.
- **21**ST **Century Schools meeting** An update on the progress of the redevelopment of Caldicot School.
- **Catchment Meeting** Meeting about the catchment area for Caldicot School. Slight changes in transport which I found acceptable.

- Severnside Area Committee A low attendance at this meeting, perhaps due to the programme board a few days earlier. Expressed my thought to many appropriate officers that more needed to be focused on wider Severnside i.e. Undy/Magor
- **Network Rail Meeting** Met with Network rail to have a presentation on the current plans for the electrification and the disruption it will cause. Both bridges in Undy will not be closed at the same time. Now have estimate dates and durations for bridge closure/improvement.
- **Full County Council meeting** huge amount of issues dealt with which can be found on council minutes. Including ALN, 21st century schools, enterprise, accounts and much more.

Constituent Issues:

- Continuing to help a constituent who has a development issue adjacent to their land. Set up
 a meeting between officers and constituent and chased up officers on written reply all of
 which has now been concluded, waiting on next step.

- Setting up processes in order to sum up the success of the dog fouling initative which was rolled out across Severnside.
- Ensured that the process was followed through in order to ensure that unsightly land is now going to be cleared up ASAP.
- Spoke to chair of MUSLA about issues with MCC and moving forward.
- Watched Undy AFC play in a cup game against Llswerry and win.
