Restore and create habitats and resilient ecological networks	 A wildlife meadow on the land surrounding the Council's Tennis & Multi Use Games Area at Sycamore Terrace was created involving landscaping, planting of 30 plus native trees, the creation of a wildflower meadow and Equalities Act compliant pathways. Past projects include financial support to the GWT in 2012 for the removal of encroaching willow in an area of Magor Marsh to enable it to be returned to a natural reed bed. An annual program of provision of large planters in and around the community planted up with pollinator friendly flowers. Work with Monmouthshire County Council, Network Rail and Natural Resources Wales a program of work to address localised flooding of December 2020 was initiated to clear debris from the Mill Stream and associated reens, culverts and flood gates etc to prevent further flooding.
Tackle negative factors: for example reduce pollution, use nature based solutions, address invasive species	 Worked with various local groups and organisation on Community Litter picks, including the Marine Conservation Society in 2016. Provision of 33 dog waste bins across the villages and an ongoing effort via Council Website and Social Media Platforms to educate and remind owners/walkers of their responsibilities to benefit the whole community. The wildflower meadow at the MUGA courts has been developed and planted, with some positive feedback from members of the public. For the first year, there was an abundance of cornflowers and poppies.
