PUBLIC FOOTPATHS NO 22 (PART) & 23 (PART) UNDY
PUBLIC PATH DIVERSION ORDER

The above order was made on **6th August 2024**. The effect of the order will be to **divert public footpath 23** running from point A (ST43768763) West South Westerly for 215m to point B (ST43558760), from B West North Westerly for 60m to join FP23 at point C (ST43498763) and to divert **public footpath 22** from point E (ST43488762) Northerly for 24m to join unaffected FPs 17 and 23 at F (ST43488764).

And create alternative Footpath 23 on a line running from point A West North Westerly for 182m to point D (ST4323887686), from C East South Easterly for 38m to point D (ST43598769), from D South Westerly for 105m to join FP23 at point C (ST43498763); And FP 22 from Point E North Easterly for 22m to join unaffected FP 23 at point C. All as shown on the order map.
