Over the past few years, we have managed to get a brand new Community HUB built, to the highest BREEAM sustainable building standard.

We now run the HUB with a full-time manager 7 days a week for the benefit of all local residents. The facility is available for bookings for a multitude of different group activities. These include Yoga, Pilates, Children's and Adult Ballet, Dance Classes, Fitness classes, Reading Group, Health and Social Counselling. Along with family party celebrations including birthdays, anniversaries, engagements, weddings and family Wakes.

Our aim was to provide a facility for the towns people to organise and run whatever groups/functions they can to improve the wellbeing, health and social interaction of the local community. Our objective over the next few years is to encourage groups to organise and run more social activities. E.g. Dances, Cinema nights, Band evenings etc.

We are also seeing increased use by local businesses for training/seminars, Antique, Stamp and Coin Fayres.

Our only source of income is the hire charges for the use of the rooms at the HUB.

Since opening in September 2023 our usage by the multitude of different activities has increased dramatically with an average of over 100 bookings and 250 hours of activities per month.

January 2025 actually saw 130 bookings and 270 hours of activities.

We Fund Raised to install a Blood Kit on the wall HUB alongside our Defibrillator. We managed to raise enough for our kit and two others, one outside the Council and another at Undy Football Club. The only other registered bleed kit in Wales, we are aware of, is one in Penarth. Hopefully never ever to be used but Magor & Undy now has three!

When the train station gets the go-ahead, we hope to hire electric bicycles to encourage visitors from a much wider area of the UK to visit the Town and the Gwent levels.
We have had and have further bookings for Antiques Valuers and Stamp & Coin Collector Fayres, which have attracted visitors from a wide area of South Wales either side of the Severn Estuary up as far as Gloucestershire.
