TEMPORARY TRAFFIC REGULATION NOTICE 2026**

NOTICE IS HEREBY GIVEN that **MONMOUTHSHIRE COUNTY COUNCIL** of County Hall, The Rhadyr, Usk, NP15 1GA ("the Council") **Intends to make** an order pursuant to the powers conferred by Section 14(1)(a) of the Road Traffic Regulation Act 1984

1. The Order shall come into operation on the **23rd February 2026** and will continue to be in force for a period not exceeding 18 months or until the works which it is proposed to carry out have been completed, whichever is the earlier. It is anticipated that the works will be completed **between 23rd February 2026 and 5th March 2026, operating between 20:00 – 06:00.**
2. The order is necessary **for M4 J23A Magor Scheme for Ameys works to take place** in a safe manner at the location. Reasonable access will be maintained for properties and businesses fronting the affected lengths of road during the period of the closure.
3. The effect of the order will be to temporarily close **a section of A4810 Magor Interchange, Magor, Monmouthshire.**
 - I. **Magor Interchange Roundabout to be closed from Eastbound On Slip to its junction with West Bound On Slip.**
 - II. **M4 JUNCTION 23A TO JUNCTION 24 Westbound ON SLIP**
 - III. **M4 JUNCTION 23A FROM JUNCTION 23 Westbound OFF SLIP**
 - IV. **A4810 Magor Interchange, Magor** from its junction with B4245 Newport Road to its point with the Magor Interchange Roundabout, approx distance ~215m
4. A signed diversionary route will be in place as follows:- **B4245, A4810, A48, Coldra Roundabout, M4 and vice versa.**
5. This order may be cited as the **A4810 Magor Interchange, Magor Monmouthshire Temporary Traffic Regulation Order 2026**
6. By virtue of Section 16(1) of the Road Traffic Regulation Act 1984 a person who contravenes a restriction or prohibition imposed under Section 14 of the Act shall be guilty of an offence.
