1. Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2021-22 was £8.41 per elector.

In 2021-22, the Council made payments totalling £150.00 under section 137. These payments are included within 'Other payments' in the Accounting Statement.

Audit opinion – Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources (value for money).

Basis for Qualification

Accounting Statement

In my opinion, the accounting Statement has not been prepared in accordance with proper accounting practice and does not fairly present the Council's income and expenditure and financial position for the year:

- The Accounting Statement has not been prepared in accordance with proper practice. Councils with receipts and payments in excess of £200,000 each year must prepare their accounts on an income and expenditure (accruals) basis.
- The Accounting Statement has been prepared on a receipts and payments (cash accounting) basis.

Other matters arising and recommendations

I draw attention to the negative responses provided by the Council in its Annual Governance Statement. The Annual Governance Statement sets out the minimum standards that a council should reasonably be expected to achieve. The Council will need to ensure that it addresses these deficiencies in future years.

There are no further matters I wish to draw to the Council's attention.
