#### **PUBLIC OPEN FORUM**

In accordance with the Councils Standing Orders 3.3 a period of not more than 15 minutes for Members of the Public is provided to ask questions and make representations about business on this agenda. Persons who wish to make comment shall not speak for more 5 minutes and they will not take part in any debate.

A member of the public read a statement on behalf of another resident relating to Agenda items 7.1 and 8.1. The statement related to a request to restrict contact with the Council office. The Chair, Cllr F Taylor requested on several occasions that the member of the public curtail their representation as she felt it strayed into employment matters.

<u>A member of the public raised</u> concerns relating to an unauthorised occupation of land in Magor over this last weekend. There were also concerns raised about public disorder.

#### 38 Chairs Announcements

Cllr F Taylor responded to the concerns raised in public forum regarding persons occupying private land without lawful consent.

There is no permission or consent for any persons to occupy the land.

The land is privately owned by several private landowners and following enquiries, ownership has been identified and advice sought from Monmouthshire County Council. The landowner carries the responsibility for and power over their own land and it is for them to take the lead.

Cllr Taylor confirmed that the Council was aware of the serious incidents and were actively engaging with Gwent Police to ensure the matters were appropriately dealt with.

The Town Council has been engaging with businesses and had advised that any incidents of disorder need to be reported directly to the Police. The Town Council whilst have no powers in directly deal with incidents can provide advice & support as well as passing information on to relevant parties.

#### 41 Hybrid Meeting Equipment

41.1 To note that equipment has been purchased at cost of £306.00 against budget line 4225/110 (Hybrid Meetings) to facilitate and improve provisions for inclusivity at Town Council Multilocation meetings.

The power to spend being Section 111 Local Government Act 1972 – Power to do anything that will facilitate, be conducive to or incidental to the discharge of the Council's powers and functions.

The Clerk provided details of equipment purchased to assist with the management of Hybrid Meetings.

Cllr D James welcomed the provisions and requested review and re-evaluation of equipment if required with provisions to be considered when setting budget for next financial year.

#### **Resolution:**

The decision of the clerk to proceed with the acquisition of the equipment in line with his delegated authority under financial regulations was noted and ratified.
